The Ocilla/Irwin Planning Advisory Commission recommends the Zoning Change requested by Mr. Jethro Ellison be denied.

Mayor Matt Seale explained the Council could vote to agree or disagree with the Commission’s decision.

Mayor called for a motion.

Motion by Councilman Steven Hudson and 2nd Councilwoman Claire Clayton to follow the recommendation of the Ocilla/Irwin Planning Advisory Commission and denied the zoning change from R14 to R8M which means the zoning will remain R14 for 214 N Alder Street.

Dear Honorable Mayor and Council:

We have reviewed the bids received at City Hall, at 2:00 p.m., local time on August 25, 2020 for construction of the referenced project. Two (2) bids were received. The following is a summary of the two (2) low responsive bids.

1.	A.C. Blount Concrete Services, Inc. P.O. Box 1523 Moultrie, GA 31776	\$364,715.00
2.	Greene Concrete Construction, Inc. P.O. Box 1406 Fitzgerald, GA 31750	\$379,641.80

A certified tabulation of all bids received is attached. A copy of the tabulation has been emailed to each bidder for their information. Each responsive bidder submitted a 5% bid bond from a surety company listed on U.S. Treasury Circular 570 (07/01/2020). The low bid of \$364,715.00 is not within the total of the federal contribution of \$237,600 and the City of Ocilla's required matching funds of \$59,400. Therefore, the City of Ocilla shall be solely responsible for any and all amounts in excess of GDOT's maximum obligation.

The lowest responsive bidder is pre-qualified as eligible for work with the Georgia Department of Transportation. Keck and Wood, Inc., therefore, recommends contract award to A.C. Blount Concrete Services, Inc. in the amount of \$364,715.00 for the construction of SR 32 From CS 252/Oak Street to CS 538/Roosevelt Street.

Auto Owners Insurance Company is the surety company for the recommended bidder's bid bond and will likely be the surety company used for the payment and performance bonds on the project. In addition to being listed on the U.S. Treasury Department Circular 570, the surety is shown as being licensed in Georgia, having an Active/Compliance status, and with an underwriting limitation that is greater than the bond amount. Please note that in accordance with Georgia Law (OCGA 36-91-40 (a)(2)), the City must have an "officer of the government entity" to "approve as to form and as to the solvency of the surety" for the proposed surety company named above. We recommend that your legal counsel be contacted to handle or suggest the
