### Georgia Municipal Association Representative/Emily Davenport

Emily Davenport, Member Service Consultant for GMA, for District 11. GMA serves all 537 cities in the state of Georga. Ms. Davenport stated they are big on advocacy, service, and education. She mentioned all the services they provide and asked if anything is needed to please reach out to her.

### Sista Girl Birth Initiative/Kristina Cheek

Kristina Cheek, Founder and Executive Director of Sista Girl Birth Initiative, stated that her organization is community base. Her focus is to improve maternal health disparities and low breastfeeding rates in rural South Georgia. Her mission is to guide birthing families towards reclaiming their birth experience by fostering safety, joy, and well-being for both parents and babies. She has served over 500 families.

The organization is on a mission to rally and uplift black dads, championing family well-being nurturing parental development, and being a rock solid source of strength.

Ms. Cheek asked the council to help spread the word about what she does and she would love to train women in this area.

#### TAN Resolution

#### Regular Monthly Meeting Date

Council Member Clae Wynn asked to change the Regular Monthly meeting date do to conflict with the County Commission Meeting date.

Council Member Clae Wynn made a motion to change the Regular Monthly Meeting date to the third Monday effective April. Mayor Pro Tem Chris Paulk seconded the motion; which passed with Council Member Clae Wynn, Mayor Pro Tem Chris Paulk, Council Member Lisa Cook, and Council Member Lemora Moses all voted for the motion.

### Utility Truck

Mayor Pro Tem Chris Paulk stated the Water Department needs a utility truck. He stated the Director is driving his personal truck to conduct City business. Mr. Paulk presented quotes from Fitzgerald Chrysler Dodge Jeep Ram dealership, Fitzgerald Ford dealership, and a utility truck that Irwin EMC is selling for \$15,000.

County Clerk Donna Prather gave a report on collections for delinquent and current utilities, taxes, and business licenses.

Mayor Pro Tem Chris Paulk stated he had a complaint about potholes on McNeil Road and dog catching on East 7<sup>th</sup> Street.

Council Member Clae Wynn asked if a video conference can be set up with Hyper Web software owner Marc Kallaoun regarding financial documentation that the City needs to complete the audit.

City Clerk Donna Prather stated she would contact Mr. Kallaoun regarding the information.
